The subjects are located in an historic area of Kirkwall, adjoining the Sherriff Court, on the grounds of the Bishop and Earls Palaces adjacent to St Magnus Cathedral. Kirkwall is the largest town on the islands of Orkney located 16 kilometers from mainland Caithness. The island is connected to the mainland through regular ferries and air links through Kirkwall airport.

DESCRIPTION

A grand two storey office premises of traditional stone construction under a pitched and slated roof. The property was previously operated as a dentist. Many of the attractive historical features of the property remain intact.
